Guajardo is currently a Partner at DGA Group in Washington, D.C., where he advises multinational companies on how to navigate political risk, regulatory landscapes, and geopolitical shifts, particularly in Latin America and China. He also co-chairs the Aspen Institute's Global Cybersecurity Group.

A fluent English and Spanish speaker with global gravitas, he is a sought-after commentator on international affairs, regularly contributing to major media outlets. His strategic vision and diplomatic experience make him a compelling voice for audiences seeking clarity in a fragmented geopolitical environment.
